Celebration of Summer will be held at Lehmann Park, on Cedar Avenue in Lake Villa and will include a Car Show, Ribfest, and Vendors in addition to the Art Show.

Requirements: Applications are due by May 6th. Payment is due with application. Check will be refunded if applicant is not accepted. *Completely* fill out and return the application and mail with entry fee payable to Village of Lake Villa – Celebration of Summer. All applicants are required to submit photos, regardless of past participation. Send 3 photos, 1 of your work, 1 of you creating your work and 1 of your display. Photos will not be returned. Send the above information to **Celebration of Summer**, P.O. Box 519, Lake Villa, IL. 60046.

All Fine Art must be 100% created by the artist selling the product. Immediate family members will be allowed to sell for the artist. No Art accepted from outside the USA. Work that is an exact copy from a wholesale company will NOT be accepted. The show jury reserves the right to refuse or remove an applicant for any reason, even after display is erected.

- Booth space is a 10 x10 foot space on grass in the park, only one artist per space. Spaces will be assigned by the committee prior to set up time. You will receive your space number at the registration table. Electric is NOT available.

Set-up: Saturday 7:30am. Spaces must be completely set up by 9:30am sharp. Your booth must stay open **until the end of the show at 3:00pm**. Each Artist is responsible for erecting, preparing, removing and cleaning their space(s).

- Tents are recommended, but not required, to protect artists and artwork from the variety of Midwest weather. If artist does use a tent, legs are required to be weighted with at least 20 pounds per leg and will be checked during setup.

- When arriving for set-up, you must first sign in at the registration table. Emergency phone # must be provided at the time of registration.

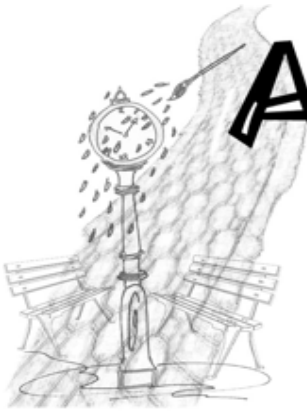
-Setup is “drop & go”, bring your set up to your spot, drop it off, go park and come back to build. All Artists must park in the Metra parking lot next to the post office.

- At no time can the handicapped spaces be blocked, this includes during set up and tear down.

- If you leave the Show early for an emergency, you must carry your display out.

Participants who violate any rules and/or guidelines will be asked to leave the show and will be banned from future shows. The Show Jury reserves the right to refuse or remove any applicant.
