Conceptual Review: Proposed Solar Farm Development

Manhard Consulting presented an overview for a proposed Solar Farm at Petite Lake Road and IL Rt. 83. The petitioner will proceed with an application for rezoning from UR1 (Urban Residential) to AG (Agriculture) of the parcel(s) and Conditional Use Permit. The project area consists of roughly 36.5 acres and will be enclosed by an 8' wire mesh perimeter fence and vegetative screening.

Staff Reports:

Dave Mohry was introduced at Fire Inspector, coming to the village from Northbrook FD. Public Works reports the Tree planting on Grand Avenue will be suspended until spring. There position of Maintenance Worker II is still open. Applicants have not met minimum requirements therefore a separate approach was requested. An audit will take place in school zones for proper signage. Loffredo Park pergola will be installed in the near future. The police chief had a successful Night Out campaign. Two officers received awards from AIM Sgt Dion and Officer Davie. The property at 855 Grand Ave submitted an application for a used car dealership. Grass Lake Sidewalk project received 5 bids, 2 of which were under budget. Lake Villa will be profiled on WGN in the near future. Two agenda items were tabled for further information.
