1. CALL TO ORDER AND ROLL CALL

3. APPROVAL OF MINUTES

Commissioner Coia made a motion to approve the minutes of the June 20, 2024 Plan Commission meeting. The motion was seconded by Commissioner Cramond and approved unanimously by voice vote.

4. <u>Public Hearing</u>: Conditional Use Permit for a Recreational Accessory Use at 895 E. Grand Avenue

Chairman Kressner announced that petitioner had withdrawn their application.

5. <u>Public Hearing</u>: Rezoning and possible Conditional Use Permit for a Residential Planned Development at 0 Cedar Lake Road
