# Compensation

Starting Salary Range: \$55,263 - \$65,378 Full Salary Range: \$55,263 - \$75,494

Salary Range dependent upon most recent adopted Village Pay Plan. Non-Exempt position with health and dental benefits. Village paid life insurance policy. Deferred pension plan through IMRF and opportunity provided to participate in a Section 457 deferred compensation retirement plan. Eligible for salary adjustment after six (6) month probationary period. Salary range adjusted at the start of every fiscal year.

# **Position Summary**

This position is a member of a work crew performing semi-skilled and unskilled labor work within the Public Works function to repair and maintain Village streets, buildings, grounds, rights-of-ways, equipment and water and sewer facilities.

The main duties of this position will focus on the Water and Sewer Division.

Under the direct supervision of the Superintendent of Public Works, work involves the construction, repair and maintenance of Village streets, water and sewer facilities, public buildings and grounds.

#### **Job Content**

The following major duties and related tasks have been identified as being essential to the proper and effective performance of the job. The Maintenance Worker II should expect to perform all of the following duties. While the following major duties have been identified, other duties may be assigned from time to time as determined by the Superintendent of Public Works.

<u>Participate in the construction, maintenance, and repair of Village streets, rights-of-way, sidewalks, bike paths and street signage.</u>

#### **Essential Tasks**

1. Erect, repair, and maintain traffic signs, barriers, and traffic control markings; paint traffic control lines, crosswalks, parking stall lines, and the like on pavement; letter street markings and traffic signs, and straighten, repair or remove sign posts, and bolt or screw signs on posts or other supports.

- 2. Maintain roadsides and other Village grounds and parks; cut lawns, prune shrubs and trees, dispose of leaves and refuse, apply mulch, and sod, seed and weed lawns and planted beds; and remove trees or brush.
- 3. Repair and maintain Village streets, and parking lots; repair roadways and parking lots by filling cracks and holes with gravel or asphalt.
- 4. Inspect and repair parks equipment.

# <u>Participate in the maintenance, repair and inspection of all Village water distribution,</u> wastewater treatment and storm sewer systems.

#### **Essential Tasks**

- 1. Install, repair, and maintain storm inlets, manholes and other storm sewer structures; cut and regrade ditches, and repair or replace driveway culverts.
- 2. Perform water meter readings, meter installations, and meter repairs.
- Perform labor work in support of all water and wastewater operations, including; maintenance and repair of wastewater pumping stations, well houses, water towers, water mains, fire hydrants, sanitary sewers and other water and wastewater equipment and facilities.
- 4. Collect operational data at the water supply well houses, wastewater pumping stations and the wastewater treatment facility and prepares/maintains all operational records and reports.
- 5. Troubleshoot and resolve operational problems.

#### Participate in snow removal operations from Village roadways, parking lots and sidewalks.

#### **Essential Tasks**

- 1. Remove snow and ice from parking lots, streets, and other public areas and spread salt or other materials on pavement surfaces.
- 2. Clear sidewalks around Village facilities and other locations.
- 3. Perform permanent and temporary repairs to damaged mailboxes.
- Load vehicles with salt.

### Assist in the completion of various operational functions and tasks.

#### **Essential Tasks**

1. Perform a variety of semi-skilled and unskilled tasks including, but not limited to pavement patching, tree trimming, landscaping, painting, watering, sign maintenance, road kill and trash removal, graveling, ditching, hydrant flushing, street light

- maintenance and other electrical repairs, facility housekeeping and other duties as assigned.
- 2. Complete various reports including daily performance activity report, vehicle checklists, call out reports, snow and ice control reports, and various other reports and forms as required.
- 3. Assist with the training and development of employees in lower classifications including seasonal employees.
- 4. From time to time, lead a crew of employees to complete various tasks and projects as assigned.

#### **Work Content**

The position of Maintenance Worker II reports directly to the Superintendent of Public Works. The position is responsible for performing operational tasks of all public works related activities. The position is responsible for complying with all organizational policies, procedures and processes. The position consists primarily of predictable, routine tasks, but from time to time, unpredictable, non-routine tasks are required.

The individual in this position is expected to have effective written and verbal communication skills. The Maintenance Worker II is expected to use discretion and take initiative in dealing with a wide range of problems with direction and supervision from the Superintendent of Public Works. This position represents the Village when interacting with citizens, business owners, developers, contractors and other public officials.

The work is a combination of inside and outside work, but primarily outside work. The inside work consists of facility maintenance, facility inspections, and cleaning, with some exposure to physical discomforts. The individual may be called outside at anytime when performing the job duties of the position where the individual will be exposed to physical discomforts associated with changes in weather such as rain, cold, snow, heat or discomforts associated with noise, dust, dirt and the like. Work frequently produces mental/visual fatigue associated with various duties and responsibilities. Work sometimes generates significant levels of stress and requires work under pressure. Equipment used in this position includes the use of vehicles and equipment that may include motor vehicles, dump trucks, snowplows, backhoes, front end loaders, skid steers, saws, bucket truck, crane truck, air compressor, hand tools and other miscellaneous equipment.

As required, this position shall perform all labor tasks in conformance with Village safety and administrative policies, in order to repair, maintain or reconstruct a variety of Village roads,

buildings, grounds and equipment. The position is subject to 24-hour callout and may be required to work weekends and holidays.

The Maintenance Worker II must have experience in municipal public works operation. The position will require the individual to be familiar with public works, the structure of municipal organizations, state and federal laws governing local governments, the delivery of public services and public relations activities.

# **Work Requirements**

This position requires an individual to read, write, hear, and speak the English language sufficiently to effectively meet performance expectations. The position requires an individual walk, sit, stand, operate the equipment required for the position and perform the essential functions listed in this job description. The individual in this position must possess the minimum skills, knowledge and abilities required for the position.

Graduation from high school or GED equivalent and two to three years experience in public works, construction management or water and wastewater systems, or any equivalent combination of training and experience that provides the following minimum knowledge, skills and abilities:

- Knowledge of the principles and practices of public works.
- Knowledge of occupational hazards and safety precautions of work.
- Must possess a valid driver's license issued by the employee's state of residency.
- Must possess a Class B "CDL" with a tanker and airbrake endorsement with the ability to obtain a Class A "CDL" within 12 months.
- Ability to understand and follow instructions, both verbal and written.
- Ability to keep accurate records and perform basic math.
- Ability to apply basic computer skills.
- Ability to work in a team while performing semiskilled and unskilled work.
- Possession of an Illinois Environmental Protection Agency (IEPA) Class C water operator license, will consider a Class D.
- Illinois Arborist Association (IAA) Certification, Occupational Safety & Health Administration (OSHA) Competent Person and Illinois Pesticide Applicator License preferred, but not required.
- Ability to lift a minimum of 80 pounds from the floor.
- Must possess a flagger safety certification.
- Must possess CPR, AED and first aid certification.
- Familiarity with GIS mapping and reading prints.
